



**FAST TRACK PROGRAMME TO INNOVATE IN
BARCELONA - CATALONIA'S LIFE SCIENCES HUB**

ADVANCED THERAPIES AND PRECISION MEDICINE

SCOPE OF THE PROGRAMME

ACCIÓ - Catalonia Trade and Investment proposes a multimarket programme aimed at **positioning Catalonia as a hotspot destination in the field of advanced therapies and precision medicine** for **startups, scale-ups and other organisations** from Belgium, Denmark, Finland, France, Italy, Netherlands, United Kingdom, Ireland, Sweden, Switzerland, Israel, Canada and the USA.

Participating companies will be offered the opportunity to **establish key connections, validate their technologies and receive tailored support for their R&D, innovation and expansion plans**. The format will be a **competition**.

- **Target company** – Basic requirements, at least one the following:
 - Minimum of series A investment in the last 3 years
 - More than €2 million in revenue
 - More than 25 employees
 - Other referent organisations in the field of advanced therapies and precision medicine with the capacity to establish meaningful R&D collaborations with Catalonia

4 PROGRAMME PHASES

ONLINE SESSION 1 Connection with key stakeholders

Session 1 aims at seizing the participants' attention by providing an introduction to the Advanced Therapies ecosystem and connecting them with key players and large corporations that can provide them with some advice on their potential project in Catalonia. Format is 30mn presentation and 1h for Q&A.



ONLINE SESSION 2 Technical session

Session 2 will connect the participants with the main partners for preclinical and clinical research in the field of advanced therapies in Catalonia, who will be able to validate and provide feedback on the participants' R&D projects. Format is 1h presentation from panellists and 1h in breakout rooms.



ONLINE SESSION 3 The access session to market, funding and talent

Session 3 is focused in presenting the following:

1) how to access Spanish-European health system 2) how to access public funding and 3) where and how to access the best talent



FOLLOW-UP Individual follow-up (After the sessions)

Individual follow-ups with each company with the support of other players. ACCIÓ will only directly manage those leads-projects that fit the right profile.

SALUT 2030

'Health 2030' project is seeking to mobilize €2 billion to promote the ecosystem's industry and pipeline, consolidate and scale up the innovative fabric in the BioRegion and transform the health system in Catalonia. The new National Centre of Advanced Therapies intends to guarantee patient access to research in advanced therapies and pave the way to conduct clinical trials in this field at Catalan hospitals

ACCESS TO HIGHLY SKILLED TALENT

Barcelona is the 1st Science City in the south of Europe (Nature Index, 2020), with 94 life science organizations, 800 research groups and 25,000 researchers.

ACCESS TO EU FUNDING

Catalonia is a top recipient of Horizon Europe projects, while the Catalonia's Health 2030 programme and the EU's Next Generation Funds offer immense possibilities for international collaborations and expansion plans in the region

ACCESS TO A VIBRANT NETWORK OF GLOBAL PLAYERS

Catalonia hosts 12 of the largest LS global companies, and concentrates over 50% of Spanish pharma and biotech activity. Spain ranks 4th worldwide in number of clinical trials, half of them being conducted in Catalonia.

INNOVATION PLATFORM IN EUROPE

Innovation in Catalonia's Health sector is powered by opportunities in public procurement for innovation, corporate challenges and one of Europe's most attractive R&D Tax incentives.

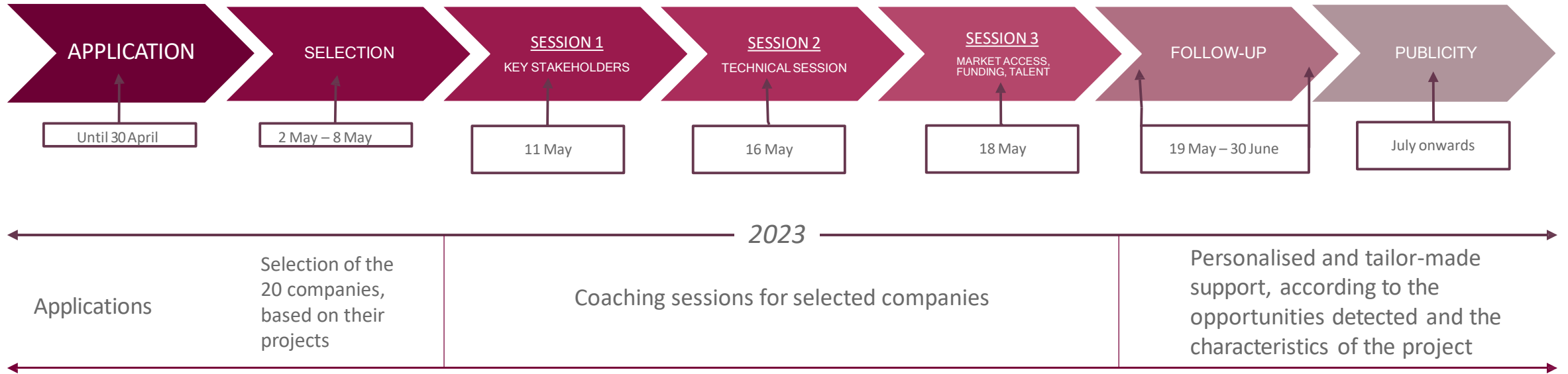
COMPETITIVE OPERATING COSTS

Barcelona's operating costs are 29.7% lower than in other top European life sciences clusters (fDi Intelligence), which contributed to a tenfold increase in investment since 2010.

GATEWAY TO THE SPANISH SPEAKING MARKET AND BEYOND

Spain is the 2nd biggest investor in Latin America, has a large network of Double Taxation Agreements and benefits from an extremely tax-efficient holding regime to structure investments in the region.

HOW DOES THE COMPETITION WORK?

The health expenditure of all Spanish-speaking markets is worth \$270B. This is a market too big to avoid, and Catalonia is the gateway to make it happen for your company, showing life sciences business requires specific talent and often lacks, so we believe that the Barcelona-Catalonia BioRegion can offer an incredibly efficient route.

Catalonia Trade and Investment will select 10 companies that will receive VIP support to land in Barcelona-Catalonia. The main stages of the programme are:

- EXPERT PANEL SESSION:** Companies will pitch their projects to a panel of experts and will receive advice on how to enter in Catalonia and Spanish-speaking markets.
- MARKET ACCESS SESSION:** The selected companies will also participate in a session about market access supported with an international advisory firm, specialised in Spain and Latin America.

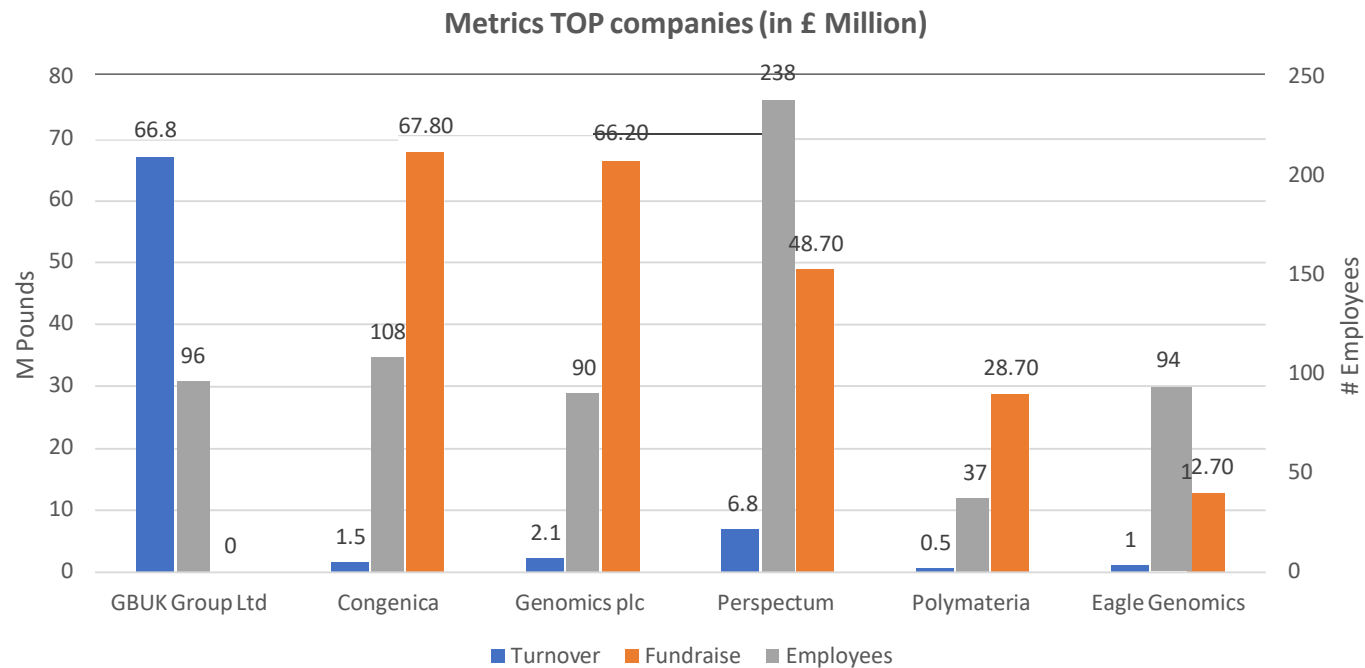
